HOW TO SUBMIT AN ITEM FOR CONSIGNMENT: All consignors must submit items via our website <http://www.hunttheshop.com>. Please provide a description of each piece, (i.e., manufacturer, size, condition, price paid, age, etc.). Up to 4 digital photos may be submitted online. Upon receipt of your submission, we will review the pieces to determine if they would be a good fit for our store. We make our best efforts to respond to consignment inquiries within 24 hours. You cannot bring items to the store before they have been accepted.

ALL CONSIGNED GOODS SHALL BECOME THE LEGAL PROPERTY OF HUNT, LLC, UNTIL SUCH TIME AS SETTLEMENT OR RETURN OF ITEMS IS MADE.

OUR PRICING: HUNT will determine the pricing of items. We take into account the style, overall condition of the piece, manufacturer, recent demand for similar/same items, historical sales of similar/same items, original purchase price and your desired price. We will work with you to get the best price. Items priced too high do not sell. We price items competitively in order to sell them within a short period of time for maximum profit.

TRADE DISCOUNTS: All items are subject to an immediate 10% discount at Point of sale to the Trade.

PRICE REDUCTIONS: After 30 days from the date of the consignment, HUNT reserves the right to reduce your item by 10% AND place it on an automatic reduction rate of 10% per month until the item is sold or picked up by the consignor.

CONSIGNMENT PERIOD/EXPIRATION: All items will be displayed for 90 days and must remain at HUNT during that period. It is the responsibility of the consignor to pick up any unsold items within three (3) days after the consignment term end date to prevent further price reductions. It is not the responsibility of HUNT to contact the consignor with regards to the end date. Any item not picked up by the consignor after 120 days from the original consignment start date will become the property of HUNT without compensation to the consignor.

ITEMS LOST, STOLEN OR DAMAGED: All reasonable care will be taken of articles consigned with HUNT however they are left at the consignor's risk and compensation will not be due to any consignor for lost, stolen or damaged items. HUNT or their affiliates are not responsible for damages or loss due to fire or theft.

PAYMENT: HUNT retains 50% of the final sales price received, and the remaining 50% will be paid to the consignor. Checks are mailed out during the month following the month in which the item(s) sold.

DELIVERY/PICK UP: We do not provide pickup services for your items. For your convenience, we can provide you with a recommended mover. Delivery of any item must be scheduled in advance prior to delivery.
